Director Report Candis Stiles Budget Update I have been in contact with the budget committee since our last Extension Board meeting because we had received two requests from the Shawnee County Commissioners. The first was asking for a voluntary reduction because after all department budgets were received, they were 7.5 million from a flat mill levy. The budget committee looked at our request and we offered \$1,750 cuts coming from the Rent and the Benefits lines. The commissioners were very grateful for our taking a second look. After a few departments did this, they were still looking for 2.5 million dollars in cuts, so they asked all departments and partners to let them know what a 5% cut would mean for their department. Again, our Budget committee looked at my draft of a 5% cut, it included the summer 4-H Intern, Travel, Rent and Salary Increase cuts for 2026. Thankfully, we were not asked for our scenario. As it stands, the commissioners have gotten the county budget down to a one mill increase. If they want to stay flat, they have another 2 million to go. The public budget hearing is Sept. 8th.

Renewal of Non-State Employer Group Health Plan, our 3-year contract expires Dec. 2025 Candis sent the three-year contract to the board members on Monday. This gives the support staff the same Health Insurance plan that the agents receive as State of Kansas employees. Chad Bullock made motion to approve, Angela Dailey seconded, motion carried.
