4-H Fair Rule Changes that were approved:

Horse Rule 1: Change to "All horses regardless of state of origin must have proof of a negative Coggins test within the last 12 months on file with the extension office." yes Change to state requirements for 2025, we are getting our rules up to compliance. Previously Coggins testing was only required for horses originating out of state, but is now

Meat Goats Entry Limit: Change to 3 exhibits in any 1 phase of the project with a limit of 6 total animals yes Entry limit is being increased to match Kansas State Fair rules, previously only allowed 2 animals per "phase"

Meat Goats Rules 2 & 3: replace the words "USDA Premise Tag" with "Scrapie Tag" and remove the phrase "per current state of Kansas regulations" yes "USDA Premise Tag" and "scrapie tag" are often used interchangeably, but "scrapie tag" is the correct term, so we are updating language. Additionally, "per current state of Kansas regulations" is unnecessary so it is being removed

Round Robin Change rule 5 to read "Each round of showmanship competition shall be limited to 10 minutes. Each Competitor will be given a numeric score based on their showmanship and animal handling abilities with 70% of the score based on their handling of the animal, and the other 30% based upon appropriate knowledge of the species and proper showmanship techniques for a total yes Clarifies how scoring is done for the competition

Sheep Entry Limit: Change to 3 exhibits in any 1 phase of the project with a limit of 6 total animals yes Entry limit is being increased to match Kansas State Fair rules, previously only allowed 2 animals per "phase"

Sheep Rule 1: replace the words "USDA Premise Tag" with "Scrapie Tag" and remove the phrase "per current state of Kansas regulations" yes "USDA Premise Tag" and "scrapie tag" are often used interchangeably, but "scrapie tag" is the correct term, so we are updating language. Additionally, "per current state of Kansas regulations" is unnecessary so it is being removed

Swine Entry Limit: Change to 3 exhibits in any 1 phase of the project with a limit of 6 total animals yes Entry limit is being increased to match Kansas State Fair rules, previously only allowed 2 animals per "phase"

Swine Rule 10: Add at end: Breed classifications are at the discretion of the swine superintendent and are based on Team Purebred and National Swine Registry standards. Registration papers are not required but will be accepted yes Creates clarification on how classes are broken out

Swine Rule 3: Change to read "Swine must be free of clinical signs of infestations or contagious disease. No health certificate or blood test is needed for any swine test" yes Combines rules 3 & 4, makes easier to understand

Swine Rule 4: remove yes Combines rules 3 & 4, makes easier to understand
